#### 1.2 Stand space rental

The net stand space rent is EUR 50 per m2.

The minimum stand size is 4m<sup>2</sup>.

#### 1.3 Co-Exhibitor

Co-exhibitors are companies/institutions that also exhibit at the stand with their own exhibits and services as well as personnel at the stand. They must be registered on the corresponding form. The fee is charged per co-exhibitor per co-exhibitor. For the amount of the fee, see item 1.1. Please refer to the registration form for the services included.

#### 1.4 The service fee is charged per stand.

The flat rate includes:

- 1 power connection (230 V/ 16A) incl. consumption
- Basic entry in the online exhibition directory (see point 3)
- Exhibitor passes (see point 2)
- 1x parking permit (car)
- Daily waste disposal (no hazardous waste)

#### 1.5 Service

- (1) All rental prices include:
- General hall lighting
- Heating/ventilation of the halls
- General security of the exhibition halls (no stand security!)
- General hall cleaning (no stand cleaning!)
- First-aid service during the event
- (2) Partition walls and stand construction are not included in the stand rental and must be ordered separately from the organizer at the exhibitor's be ordered separately via the organizer.
- (3) The exhibitor may order additional services from the organizer. If the exhibitor has ordered services, the rent or installation and consumption shall be at his expense.
- (4) The companies commissioned through the agency and with the consent of the organizer for material rental and installation are authorized to installation are authorized to provide their services to the exhibitor.

2. Exhibitor passes For up to 20  $\,\mathrm{m}^2$  of rented stand space, the exhibitor is entitled to 2x free exhibitor passes; for every additional 10 m<sup>2</sup> of stand space or part thereof 1x free exhibitor pass (max. 15 passes). Additional exhibitor passes can be ordered from the organizer at a price of € 18.00 (plus VAT) per pass.

Exhibitor passes are only valid during the event.

#### 3. List of exhibitors

The entry in the list of exhibitors is part of the registration. The exhibitor is obliged to make a basic entry in the alphabetical list of exhibitors.

### 4. Advertising at the stands

The operation of loudspeaker and music systems as well as video and photographic presentations on the stand requires the prior approval by the organizer. This permission will only be granted on condition that surrounding exhibitors are not impaired. Printed matter and advertising material may only be displayed within the rented stand, but not in the hall aisles or on the exhibition grounds.
